



Seasonal Resources Capacity eBulletin Board Instructions

Introduction

The **Seasonal Resources Capacity eBulletin Board** (“eSRA”) facilitates Project Sponsors with capacity resources having single-season capability (e.g., a summer-only resource) to find a partner (e.g., a winter-only resource) to participate in a primary Forward Capacity Auction through a Composite Offer (i.e., Offer Composed of Separate Resources – [see Tariff Section III.13.1.5.](#)). To participate in the Forward Capacity Market, capacity resources must provide a consistent monthly quantity of capacity, which could be composed of separate resources combined together. For example, Real-Time Demand Response Resource that plans to cycle air-conditioning use, which is only available in the summer season, can partner with the excess winter capability of a combined-cycle generation unit in order to provide a consistent monthly MW quantity that could be offered into the Forward Capacity Auction.

The purpose of this document is to provide an overview of eSRA along with simple instructions for maintaining an offer in the system and showing interest in an offer.

Authorized Users

All NEPOOL Participants have the authority to access eSRA after registration. For the purpose of these instructions, “Maintainer” will refer to an individual who will post on eSRA capacity resources with single-season capability with which partners are being sought, and “Viewer” will refer to an individual viewing the list of available capacity resources with single-season capability and will contact the Maintainer to see if a partnership can be arranged to form a Composite Offer.

Registration

To register for access to eSRA, click on the “Register Now” link on the Log in page (http://www.iso-ne.com/markets/othrmkts_data/fcm/esra/default/main.action).

Using the e-mail address provided and the password received, log in to eSRA.

If you forget your password, click on the “Forgot your user name or password?” link. Your user name is the e-mail address provided when you initially registered. If you’ve forgotten which e-mail address you provided, you’ll need to re-register. If you remember the e-mail address you provided, but can’t remember your password, provide the e-mail address and a new password will be e-mailed to you.

Offers Table

The offers table is separated into three tabs. Each column in each table can be sorted by clicking on the column title (except the “Action” column, which is the last column on the table).

All Offers Tab

The “All Offers” tab lists every offer entered into the system. The information provided in the offer is the characteristics of the resource the capacity owner is offering as a potential partner to a composite offer. The characteristics of an offer are:

- **Offer ID:** a unique identifier that is automatically assigned to each offer
- **Auction:** The auction for which this capacity resource needs a partner(s) – e.g., Primary Forward Capacity Auction (Commitment Period 2012/2013)
- **MW Amount:** Anticipated Qualified Capacity amount of this resource (in MW)
- **Season:** The season of this capacity resource (e.g., summer or winter)
- **Class:** The classification of this capacity resource (e.g., New or Existing)
- **Type:** The capacity resource type (e.g., generation, intermittent, import, Demand Resource type)
- **Location:** The location of this capacity resource by Load Zone

The offer can only be edited or deleted by the capacity owner.


